- c) authorise the Owner and/or its agents to insert and complete all particulars herein and I/we agree to be bound by the same notwithstanding that I/we may not have had any notice of the same;
- d) if the Hire-Purchase Agreement is subject to the Hire-Purchase Act Cap.125, I/we declare that before the signing of this offer, I/we have received a written summary of my/our financial obligations in the form prescribed in the Second Schedule of the Hire-Purchase Act Cap. 125;
- e) agree to the collection, use and disclosure of my/our personal data as necessary by the Owner or its representatives, employees, any affiliate company (such as but not limited to the Owner's parent and subsidiary and related companies), or its authorised dealers and/or other third parties (the "Operator") contracted by the Owner or its affiliates including the Operator's agents/contractors, authorised by the Operator to process personal data for the purpose(s) of (a) entering into, executing and performing of this proposal and the respective Hire-Purchase Agreement; (b) marketing of products and services; (c) prevention of crime (including but not limited to fraud, money-laundering and bribery); (d) research, benchmarking, statistical analysis and customer satisfaction surveys and (e) post sale services, such as customer loyalty programs;

 - (iii) authorise and give full consent to the Owner and/or Operator, sole and absolute discretion to conduct credit checks on me/us including making inquiries with any credit bureau or other parties in relation to this application and any matters relevant to this application, which the Owner may consider necessary or deem fit in its sole and absolute discretion;
